INSTRUCTIONS TO REQUEST FOR MISCELLANEOUS INSPECTIONS
(Revised July 2017)

Miscellaneous inspections not covered by an issued electrical, plumbing, or building permit can be obtained pursuant to Maui County Code (MCC) 16.18A.107-2(b), 16.20A.200, and 16.26B.109.3.7.1, Miscellaneous Inspections. Miscellaneous inspection fees are \$68 for a minimum two hours, and \$34 per hour, or fraction thereof, if additional time is required to complete the inspection, for building inspection of each structure. Miscellaneous inspection fees are \$60 for a minimum two hours, and \$30 per hour, or fraction thereof, if additional time is required to complete the inspection, for electrical and plumbing inspections for each structure.

Finalize Permit.....	\$68 for building inspection \$60 for electrical or plumbing inspections

**Exception: Plumbing and Gas permits are regulated by the Plumbing Code and, therefore, considered a single inspection type*

State Dept. of Health Licensing of Adult Residential Care Homes or Special Treatment Facility.....	Exempt per MCC 16.26B.109.3.7.1 (1)
State Dept. of Human Services Licensing of Foster Child Care Institutions and Adult or Child Care Centers.....	Exempt per MCC 16.26B.109.3.7.1 (2)
Liquor License Requirement	\$188
Short Term Rentals.....	\$188
Bed and Breakfast.....	\$188
Other	\$68 for building inspection \$60 for electrical or plumbing inspections

Note: If additional time is required to complete the inspection, the applicant will be notified of additional fees to be paid before the certificate of occupancy or comment letter will be issued. A separate request for miscellaneous inspection is also required for each structure. Payment is to be made payable to "COUNTY OF MAUI".

Required Submittals:

1. Completed Request for Miscellaneous Inspections form(s). One (1) form per structure.
2. Miscellaneous inspection fee(s).
3. One (1) scaled and detailed site plan on 8 ½" x 11" size paper (minimum) designating placement of structure(s) on property.
4. One (1) scaled and detailed floor plan(s) of area(s) to be inspected on 8 ½" x 11" size paper (minimum).
5. Notarized letter of authorization from fee owner, or copy of lease agreement, if applicant is not the fee owner.
6. If applying for a miscellaneous inspection for Department of Health or Department of Human Services Clearance, please provide a copy of the State Application or License.
