INSTRUCTIONS FOR ORDERING TAX MAP PRINTS

Below is a COMPLETED example of an Order Form for purchasing prints of tax maps. It illustrates how you are to complete the form. Above is a blank copy of the form for you to order prints. When completing the form, do not complete any gray boxes!

Assume your name is John Doe, your address is 1234 S. Kihei Road, Kihei, HI 96753, and you want to purchase two prints of a property for which you pay taxes.

1. **First, fill in your address and the date.** Don't forget the Zip Code or the State if ordering outside of Hawaii.
2. **Next, list the number of prints of each plat (map).**
3. **Then list the zone, section, and plat numbers.** This is what is shown on your Tax bill and Assessment Notice as your tax key. We **do not need or want** your parcel number or CPR Number. We would appreciate your listing the **tax keys in sequence**.
