RESTRICTING COMMERCIAL VEHICLES FROM USING FRONT STREET (LAHAINA)

DESCRIPTION:

The Committee is in receipt of County Communication No. 05-136, from Councilmember Johnson, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.68.110, MAUI COUNTY CODE, PERTAINING TO HEAVY VEHICLES AND VEHICLE LOAD". The purpose of the proposed bill is to restrict commercial vehicles from using Front Street, between its intersection with Honoapiilani Highway at Puamana and Shaw Street in Lahaina.

REFUSE COLLECTION AND LANDFILLS

DESCRIPTION:
