Chair and Members:

Your Public Works Committee, having met on February 28, 2005, makes reference to County Communication No. 04-290, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOTS FOR THE NAOKI SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 2 along Main Street, Lot 3 along Main Street and Kaniela Street, and Lot 4 along Kaniela Street and Nani Street in Wailuku, identified as a portion of TMK: (2) 3-4-018-080.

Your Committee notes that County Communication No. 04-290 was transmitted to the prior Council at its meeting of December 3, 2004.

At its meeting of January 21, 2005, the Council referred County Communication No. 04-290 to your Public Works Committee (County Communication No. 05-11).

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director informed your Committee that the road widening lots are part of the Naoki Subdivision. Road widening Lot 2 consists of 112 square feet along Main Street, road widening Lot 3 consists of 86 square feet along Main Street and Kaniela Street, and road widening Lot 4 consists of 359 square feet along Kaniela Street and Nani Street. He noted that the lots are being dedicated to the County to comply with subdivision requirements, and all necessary improvements have been made to the property.
