Chair and Members:

Your Public Works Committee, having met on August 1, 2005, makes reference to County Communication No. 05-238, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOTS FOR THE RICHARD ANTONE SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lots 1-E, 4-A, and 4-B, along Kaupakalua Road, Haiku, identified as TMK: (2) 2-7-02:026 (portion) and TMK: (2) 2-7-02:148.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director informed your Committee that the roadway lots are part of a three-lot subdivision known as the Richard Antone Subdivision. Roadway Lot 1-E consists of 1,077 square feet, roadway Lot 4-A consists of 1,117 square feet, and roadway Lot 4-B consists of 1,706 square feet. The subdivision was granted final approval on June 24, 2005. The subdivider has elected to defer making adjacent roadway improvements pursuant to Maui County Code Section 18.20.040.A.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.

Your Public Works Committee RECOMMENDS the following:

1. That Resolution No. _____, attached hereto, entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOTS FOR THE RICHARD ANTONE SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE", be ADOPTED; and
