### **WATER USE STANDARDS AND REPORTS**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. County Communication No. 05-96, from Councilmember Dain P. Kane, relating to the matter of water use standards and reports.
2. Correspondence dated March 8, 2005, from Councilmember Dain P. Kane, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATING TO WATER USE STANDARDS AND REPORTS". The purpose of the draft bill is to require private parties to report withdrawals and diversions of water and the construction of private water systems.

**STATUS:**

**WATER USE AND DEVELOPMENT PLAN**

**DESCRIPTION:** The Committee is in receipt of County Communication No. 05-38, from Councilmember Michelle Anderson, relating to the Water Use and Development Plan required by Chapter 2.88A, Maui County Code, and Chapter 174C, Hawaii Revised Statutes (State Water Code).

**STATUS:** The Committee may review the requirements of, and the status of the County's compliance with Chapter 2.88A, Maui County Code, and Chapter 174C, Hawaii Revised Statutes (State Water Code). In addition, the Committee may receive a presentation from the Department of Water Supply on long-term capital improvement projects, which may be included as components of the Water Use and Development Plan. The Committee may also consider the filing of County Communication No. 05-38 and other related action.
