PROCEDURE FOR WATER ALLOCATION

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 05-41, from Councilmember Michelle Anderson, relating to the procedure for water allocation.
2. Correspondence dated April 28, 2005, from the Maui Nui Housing Task Force Coordinator, Maui Economic Opportunity, Inc., requesting that the Committee discuss water allocation, particularly with respect to affordable housing.
3. Correspondence dated August 10, 2005, from the Committee Chair, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE ENACTMENT OF WATER ALLOCATION PLANS". The purpose of the draft bill is to establish a procedure for the enactment of water allocation plans.
