COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FOR THE 2001 PROGRAM YEAR (FISCAL YEAR 2002 BUDGET)

DESCRIPTION:

By County Communication No. 00-239, the CDBG Coordinator transmitted: (1) Community Development Block Grant Program Fact Sheet, 2001 Program Year; and (2) County of Maui 2001 Consolidated Plan (CDBG) Submission Schedule. The Committee is in receipt of a letter dated January 24, 2001, from the CDBG Coordinator, transmitting: (1) the Executive Summaries for the 2001 Grant Year (a summary that includes the listing of programs being reviewed for proposed funding); and (2) the CDBG Budget 2001 Program Year Administrative Account. In addition, the Committee is in receipt of a letter dated February 27, 2001, from the CDBG Coordinator, transmitting a proposed resolution entitled "AUTHORIZING THE FILING OF AN APPLICATION WITH THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, UNITED STATES OF AMERICA, FOR A GRANT UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM". The purpose of the proposed

resolution is to authorize the filing of an application under the CDBG Program in the amount of \$1,936,000.

STATUS:

The Committee met on March 13, 2001, and recessed the meeting to March 15, 2001. After receiving public testimony and project overviews from each applicant for CDBG funds, the Committee deferred the matter pending further discussion. The item is being scheduled to allow the Committee to consider whether to recommend adoption of the proposed resolution. The Committee may also consider other related action, including the filing of County Communication No. 00-239.
