PROPOSED BUDGET FOR FISCAL YEAR 2002 FOR THE COUNTY OF MAUI

DESCRIPTION:

Pursuant to the Charter of the County of Maui, by letter dated March 15, 2001, the Mayor transmitted documents relating to the proposed budget for Fiscal Year 2002 for the County of Maui. Included in the transmittal are the following documents:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE OPERATING BUDGET FOR THE COUNTY OF MAUI FOR THE FISCAL YEAR JULY 1, 2001 TO JUNE 30, 2002", with Appendices A and B. The purpose of the proposed bill is to appropriate estimated revenues for the operating and capital improvement budget. Incorporated within the proposed bill are Appendix A, Grant Revenues and Special Purpose Revenues, and Appendix B, Rates, Fees, and Assessments.
2. A proposed bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE CAPITAL PROGRAM FOR THE FISCAL YEAR ENDING JUNE 30, 2002", with Appendices A and B. The purpose of the proposed bill is to set forth the Capital Program for Fiscal Year 2002 and for the Fiscal Years 2002 through 2007. Appendix A is a list of all pending capital improvement projects and appropriations as of December 31, 2000, and Appendix B is the proposed Capital Improvement Program for the Fiscal Years 2002 through 2007.
3. A proposed bill entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE ISSUANCE OF TWENTY-THREE MILLION SIX HUNDRED EIGHTY-FIVE THOUSAND DOLLARS (\$23,685,000) AGGREGATE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI FOR THE PURPOSE OF PROVIDING FUNDS TO PAY ALL OR A PART OF THE COST OF APPROPRIATIONS FOR PUBLIC IMPROVEMENTS OF AND FOR THE COUNTY OF MAUI; FIXING THE FORM, DENOMINATIONS AND CERTAIN OTHER FEATURES OF SUCH BONDS AND PROVIDING FOR THEIR SALE; AUTHORIZING THE DIRECTOR OF FINANCE TO DETERMINE CERTAIN DETAILS OF THE BONDS; AUTHORIZING THE ISSUANCE AND SALE OF A LIKE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE AND SALE OF SUCH BONDS; AND PROVIDING FOR OTHER ACTIONS RELATED TO THE ISSUANCE, SALE AND DELIVERY OF SAID BONDS". The purpose of the proposed bill is to authorize the issuance of general obligation bonds for various capital improvement projects.
4. A proposed bill entitled "A BILL FOR AN ORDINANCE DETERMINING THAT PART OF THE PROCEEDS OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI HERETOFORE ISSUED IS IN EXCESS OF THE AMOUNTS REQUIRED FOR THE PURPOSES FOR WHICH SUCH BONDS WERE INITIALLY ISSUED, OR MAY OR SHOULD NOT BE APPLIED TO THOSE PURPOSES, AND DIRECTING TO OTHER PUBLIC IMPROVEMENTS OR AUTHORIZED PURPOSES OF THE COUNTY OF MAUI". The purpose of the proposed bill is to reauthorize the use of lapsed bond proceeds for various capital improvement projects.
5. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 8.04.076, MAUI COUNTY CODE, PERTAINING TO DISPOSAL CHARGES FOR BUSINESSES". The purpose of the proposed bill is to allow the Director of Public Works and Waste Management to waive disposal charges at the landfill for qualifying organizations participating in County sponsored events.
6. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 14.29 OF THE MAUI COUNTY CODE, PERTAINING TO PUMPING OF CESSPOOLS AND SEPTIC TANKS, AND CHAPTER 14.32 OF THE MAUI COUNTY CODE, PERTAINING TO PROHIBITED ACTS AND PENALTIES". The purpose of the proposed bill is to allow a service charge for areas where no private pumping services are available to service a cesspool or septic tank be set forth in the annual budget.
7. Booklet entitled "BUDGET PROPOSAL FISCAL YEAR 2002, JULY 1, 2001 - JUNE 30, 2002" (PROGRAM BUDGET).

STATUS: The Committee will discuss and consider revisions to the Mayor's proposed budget. The Committee may also consider other related action.

NOTE: With reference to this agenda item, one or more executive meetings pursuant to Section 92-5(a)(2), (3), (4), (6), (7) & (8) HRS, are anticipated to consider the hire, evaluation, dismissal, or discipline of an officer or employee or of charges brought against the officer or employee, where consideration of matters affecting privacy will be involved; provided that if the individual concerned requests an open meeting, an open meeting shall be held; and/or deliberate concerning the authority of persons designated to conduct labor negotiations or to negotiate the acquisition of public property; and/or consult with legal counsel on questions and issues pertaining to the powers, duties, privileges, immunities, and liabilities of the County, the Council, and the Committee; and/or consider sensitive matters related to public safety or security; and/or consider matters relating to the solicitation and acceptance of private donations; and/or deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a State or Federal law, or a court order.
