Chair and Members:

Your Committee of the Whole, having met on July 31, 2001, makes reference to County Communication No. 01-187, from the Council Chair, transmitting a proposed resolution entitled "RELATING TO PERSONNEL BENEFITS OF LEGISLATIVE OFFICERS AND EMPLOYEES".

The purpose of the proposed resolution is to provide the Council Chair with the authority to clarify and implement the personnel leave and other benefit policies for legislative officers and employees who are excluded from collective bargaining agreements and to continue personnel leave and other benefit policies that were in effect as of June 30, 2001, retroactively if necessary, until the policies are clarified or amended by the Council or Council Chair.

By correspondence dated July 24, 2001, the Chair of your Committee transmitted copies of correspondence dated July 3, 2001, from the Director of Council Services to the Council Chair and members of the Council, providing background information on the proposed resolution.

By correspondence dated July 24, 2001, the Chair of your Committee requested a copy of the executive order issued by the Mayor regarding personnel benefits for the appointed employees in the Administration.

By correspondence dated July 26, 2001, the Mayor transmitted a copy of the draft executive order concerning leaves for appointed officers and employees in the executive branch.

At its meeting, your Committee met with the Director of Personnel Services, the Director of Council Services and a Deputy Corporation Counsel.
