Chair and Members:

Your Committee of the Whole, having met on October 30, 2001, makes reference to County Communication No. 01-90, from the Council Chair, regarding the settlement of claims and lawsuits.

Your Committee is in receipt of correspondence dated October 10, 2001, from the Department of the Corporation Counsel, requesting consideration of the possible settlement of USAA's claim on behalf of John E. Quistgard, Claim No. 2000-126. Attached to the request was a copy of the claim and a proposed resolution entitled "APPROVING A PROPOSED SETTLEMENT of USAA, ON BEHALF OF INSURED, JOHN E. QUISTGARD; CLAIM NO. 2000-126". The purpose of the proposed resolution is to authorize the Department of the Corporation Counsel to settle the claim.

Your Committee notes that the claim alleges damages due to a motor-vehicle accident that occurred on November 20, 2000.

At its meeting, your Committee met with the Fire Chief, the Acting Risk Manager, and two Deputy Corporation Counsel.

There being no public testimony, your Committee proceeded to discuss the matter in regular session. A Deputy Corporation Counsel provided a brief overview of the case.

Based on the information received and the recommendation of the Department of the Corporation Counsel, your Committee voted to recommend adoption of the proposed resolution to approve the settlement.
