WEST SIDE RESOURCE CENTER

DESCRIPTION:

The Committee is in receipt of County Communication No. 00-316, from the Director of Housing and Human Concerns, transmitting a proposed resolution entitled, "ACCEPTING DEDICATION OF LAND PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept approximately 7 acres of land (located in Lahaina, Maui) from Pioneer Mill Company, Ltd. for the proposed West Maui Resource Center Project. The project is a homeless resource center and affordable rental housing facility for homeless and low-income families and individuals. The Committee is also in receipt of County Communication No. 01-54 from the Director of Housing and Human Concerns, transmitting (1) an "APPLICATION FOR HOUSING DEVELOPMENT" PURSUANT TO SECTION 201G-118, HAWAII REVISED STATUTES FOR THE PROPOSED WEST

SIDE RESOURCE CENTER”; (2) a proposed resolution entitled, “APPROVING THE WEST SIDE RESOURCE CENTER PROJECT PURSUANT TO SECTION 201G-118, HAWAII REVISED STATUTES”; and (3) a proposed resolution entitled, “DISAPPROVING THE WEST SIDE RESOURCE CENTER PROJECT PURSUANT TO SECTION 201G-118, HAWAII REVISED STATUTES.” The purpose of the proposed resolutions is to either approve or disapprove the West Side Resource Center project.

STATUS:

The Committee will meet with the Director of Housing and Human Concerns and a representative of Maui Economic Concerns of the Community, Inc., also known as Ka Hale A Ke Ola. The Committee may recommend that (1) the resolution accepting the land dedication be adopted, and (2) either the resolution approving or the resolution disapproving the West Side Resource Center Project be adopted. The Committee may also consider other related action, including the possible filing of County Communication Nos. 00-316 and 01-54.
