HAWAII MODEL ENERGY CODE

DESCRIPTION:

The Committee is in receipt of County Communication No. 99-296 from the Managing Director, transmitting a proposed bill entitled, "A BILL FOR AN ORDINANCE AMENDING THE MAUI COUNTY CODE, PERTAINING TO THE UNIFORM BUILDING CODE." The purpose of the bill is to repeal Chapter 53, Energy Conservation, and to incorporate the Hawaii Model Energy Code and related revisions. The Hawaii Model Energy Code establishes minimum energy efficiency standards for new construction.

STATUS:

The Committee may recommend that the proposed bill entitled, "A BILL FOR AN ORDINANCE AMENDING THE MAUI COUNTY CODE, PERTAINING TO THE UNIFORM BUILDING CODE", be passed on first reading and ordered to print. The Committee may also recommend other related action, including the possible filing of County Communication No. 99-296.
