BILL TO PROHIBIT THE EXHIBITION OF CAPTIVE CETACEANS

DESCRIPTION:

The Committee is in receipt of County Communication No. 01-232, from Councilmember Johnson, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE PROTECTION OF CETACEANS". The purpose of the draft bill is to prohibit the exhibition of captive cetaceans.

STATUS:

The Committee will consider whether to recommend passage of the proposed bill on first reading with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 01-232.
