### **VACANT PROPERTIES ON NAMAUU PLACE, KIHEI, AND ENFORCEMENT OF COUNTY CODES**

**DESCRIPTION:**

The Committee is in receipt of the following: (1) County Communication No. 98-308 from the Council Chair, transmitting a petition from concerned citizens requesting that two properties at Namauu Place in Kihei be made to comply with Chapter 9.32 of the Maui County Code, relating to community beautification; and (2) a memorandum from the Planning Committee Chair, dated January 23, 2001, transmitting correspondence from the Director of Public Works and Waste Management, directing the County's Highways Division to remove all trash from the subject properties subject to Chapter 9.32 of the Maui County Code.

**STATUS:**

The Committee will discuss this item with representatives of the Department of Public Works and Waste Management and the Department of the Corporation Counsel. The Committee may consider other related action, including filing County Communication No. 98-308.

**PC-8 IMPROVING THE PROCESS FOR UPDATING THE GENERAL AND COMMUNITY PLANS**

**DESCRIPTION:** The Committee is in receipt of the following: (1) County Communication No. 98-51 from Councilmember Alan M. Arakawa, requesting discussion on the matter of improving the process to update the general and community plans; (2) a memorandum dated February 24, 1998, from former Councilmember J. Kalani English, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTIONS 2.80A.030 AND 2.80A.050 OF THE MAUI COUNTY CODE, RELATING TO CITIZEN ADVISORY COMMITTEES". The purpose of the draft bill is to have the citizen advisory committees become the final body to review a community plan prior to referral to the Council; (3) a memorandum dated May 5, 1998, from Councilmember Alan M. Arakawa, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE REPEALING CHAPTER 2.80A OF THE MAUI COUNTY CODE AND ADOPTING A NEW CHAPTER 2.80A RELATING TO AMENDING AND UPDATING GENERAL AND COMMUNITY PLANS". The purpose of the draft bill is to incorporate deadlines into the general and community plan update process.

**STATUS:** The Committee is not expected to take action on this item. Rather, the Committee will seek input regarding ideas and strategies to improve the general and community plan update process.
