HALEAKALA MOUNTAIN MASTER PLAN

DESCRIPTION:

The Committee is in receipt of the following: (1) County Communication No. 97-110 from Councilmember Alan M. Arakawa, requesting that the matter of a Haleakala Mountain Master Plan be referred to the Planning Committee; and (2) a memorandum from the Planning Committee Chair, dated February 12, 2001, transmitting a proposed resolution entitled "URGING THE STATE OF HAWAII TO FUND MASTER PLANNING FOR HALEAKALA". The purpose of the proposed resolution is to request that the State provide funding for a Haleakala High Altitude Observatory Site Master Plan and a Coordinated Broadcast Facility Master Plan.
