Chair and Members:

Your Parks and Recreation Committee, having met on October 31, 2001, makes reference to a Miscellaneous Communication dated May 21, 2001, from the County Clerk, referring to the matter relating to fees for community centers.

By correspondence dated October 2, 2001, your Committee Chair requested that the Department of Parks and Recreation provide recommendations for potential changes to the Schedule of Fees and Deposits for use of County park facilities, Table 13.04.090.

By correspondence dated October 29, 2001, the Director of Parks and Recreation stated that his Department is recommending no changes to the Schedule of Fees and Deposits for use of County park facilities.

At its meeting, your Committee met with Director of Parks and Recreation, the Budget Director, and a Deputy Corporation Counsel.

The Director of Parks and Recreation provided your Committee with an overview of the matter. He reiterated that the Department is recommending no changes to the Schedule of Fees and Deposits for use of County facilities for the Fiscal Year 2003 Budget. However, he did suggest that an asterisk be added before the \$75 fee for Type V "Pavilions w/out Kitchen and Bandstand", to indicate that the fees will be as shown in the schedule or ten percent of gross receipts, whichever is greater.

Your Committee noted that the Department of Parks and Recreation is aware of the demands on County parks and facilities. Therefore, the Department could best determine if the fees and deposits are sufficient to cover costs of operation and clean up. Your Committee further noted that if the Department does not require a modification to the fees and deposits, your Committee would support the recommendation.
