PROPOSED BILL RENAMING THE WAR MEMORIAL BASEBALL FIELD NO. 3 AS THE "VERNON A. CORREA BASEBALL FIELD"

DESCRIPTION:

The Committee is in receipt of County Communication No. 00-273, from the Director of Public Works and Waste Management, transmitting a bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, RELATING TO NAMES OF PUBLIC FACILITIES". The purpose of the proposed bill is to name the War Memorial Baseball Field No. 3 in honor of Vernon A. Correa.

STATUS:

The Committee previously met on this matter on January 31, 2001 and deferred action, pending an opportunity to meet with the proposer and honoree. The item is being scheduled to allow the Committee to consider whether to recommend passage of the proposed bill on first reading. PR-6 PROPOSED RESOLUTION AUTHORIZING THE USE OF HOOKIPA BEACH PARK (RED BULL "KING OF THE AIR" KITE SAILING CONTEST, SEPTEMBER 10-20, 2001)

DESCRIPTION: The Committee is in receipt of County Communication No. 01-57, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "AUTHORIZING THE USE OF HOOKIPA BEACH PARK BY MIKE WALTZE PRODUCTIONS/RED BULL NORTH AMERICA". The purpose of the proposed resolution is to authorize Mike Waltze Production/Red Bull North America the use of Hookipa Beach Park for its Red Bull Kite Sailing Contest Event and Exhibition from September 10 through 20, 2001. Pursuant to Section 13.04.130(B), Maui County Code, Type V (profit-making) activities, which are to be held in excess of three consecutive days, requires Council approval by resolution.
