HSED-17 PROPOSED BILL AMENDING CHAPTER 6.04, MAUI COUNTY CODE, AS IT RELATES TO DOG REGULATIONS--DANGEROUS DOGS, IMPOUNDMENT AND PENALTIES

DESCRIPTION: The Committee is in receipt of County Communication No. 02-207, from the Director of Housing and Human Services, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 6.04, MAUI COUNTY CODE AS IT PERTAINS TO DOG REGULATIONS--DANGEROUS DOGS, IMPOUNDMENT AND PENALTIES". The purposes of the proposed bill are to clarify that dogs designated as "vicious" dogs prior to the enactment of Ordinance 2922 shall be redesignated as "dangerous dogs" and incorporate various technical amendments.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 02-207.

HSED-16 BILL TO PROHIBIT THE EXHIBITION OF CAPTIVE CETACEANS

DESCRIPTION: The Committee is in receipt of County Communication No. 01-232, from Councilmember Johnson, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE PROTECTION OF CETACEANS". The purpose of the draft bill is to prohibit the exhibition of captive dolphins, porpoises, and whales ("cetaceans").

STATUS: The Committee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 01-232.
