COMMUNITY PLAN AMENDMENT FOR THE PROPOSED WAIPUILANI ESTATES SINGLE-FAMILY RESIDENTIAL PROJECT (KIHEI)

DESCRIPTION:

The Committee is in receipt of County Communication No. 04-13, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND THE KIHEI/MAKENA COMMUNITY PLAN AND LAND USE MAP FROM MULTI-FAMILY TO SINGLE FAMILY FOR PROPERTY SITUATED AT KIHEI, MAUI, HAWAII". The purpose of the proposed bill is to approve a Community Plan Amendment for eight acres at 915 South Kihei Road as part of the 20-acre, 95-lot Waipuilani Estates single-family residential project.

STATUS:

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No. 04-13 and other related action.

NOTE:

With reference to this agenda item, one or more executive meetings pursuant to Section 92-5(a)(4), Hawaii Revised Statutes, are anticipated to consult with legal counsel on questions and issues pertaining to the powers, duties, privileges, immunities, and liabilities of the County, the Council, and the Committee.
