PLU-20 CONDITIONAL PERMIT FOR THE MAUI ECONOMIC OPPORTUNITY, INC. TRANSPORTATION FACILITY (PUUNENE)

DESCRIPTION: The Committee is in receipt of County Communication No. 02-246, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING

ORDINANCE NO. 2730 (1998), AS AMENDED, PERTAINING TO THE GRANTING OF A CONDITIONAL PERMIT TO MAUI ECONOMIC OPPORTUNITY, INC., TO OPERATE A TRANSPORTATION FACILITY WITHIN THE COUNTY AGRICULTURAL DISTRICT, FOR PROPERTY SITUATED AT PULEHUNUI, PUUNENE, MAUI, HAWAII". The purpose of the proposed bill is to grant a three-year extension of a Conditional Permit for the Maui Economic Opportunity, Inc. Transportation Facility at the former Puunene Airport Site (TMK: 3-8-008;por. of 001).

STATUS:

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions.
