Chair and Members:

Your Water Resources Committee, having met on February 18, 2004, makes reference to County Communication No. 03-137, from the Director of Water Supply, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF WATERLINE EASEMENTS FOR THE MALUHIA AT WAILEA CONDOMINIUM PROJECT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of waterline easements for the Maluhia at Wailea Condominium Project in Wailea, Maui, TMK: (2) 2-1-008:062.

By correspondence dated August 6, 2003, and January 15, 2004, your Committee requested that the proposed resolution be revised to correct the corporation name and various transfer certificate of title numbers, and to make nonsubstantive revisions.

At its meeting, your Committee met with the Director of Water Supply and a Deputy Corporation Counsel.

There was no public testimony. Your Committee received an overview from the Director as well as a written summary and maps of the easements.

Your Committee briefly discussed the location of easement number 503 adjacent to the Wailea Beach Hotel.

Your Committee recommended that the proposed resolution be revised to incorporate minor changes and correct typographical errors. Your Committee voted to recommend adoption of the revised proposed resolution and filing of the communication.
