Chair and Members:

Your Water Resources Committee, having met on January 14, 2004, makes reference to County Communication No. 03-308, from the Director of Water Supply, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A WATERLINE EASEMENT FOR THE ICHIKAWA SUBDIVISION PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of a waterline easement for the Ichikawa Subdivision in Haiku, Maui TMK: (2) 2-7-019:048.

At its meeting, your Committee met with the Director of Water Supply, a Deputy Corporation Counsel, and Carl Takumi of C. Takumi Engineering.

There was no public testimony. Your Committee received an overview from the Director of Water Supply.

Your Committee briefly discussed the intended use classification of this proposed subdivision. The subdivision is a three-lot residential subdivision owned jointly by three brothers who desire individual ownership.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.

Your Water Resources Committee RECOMMENDS the following:
