IMPROVING THE PROCESS FOR UPDATING THE GENERAL AND COMMUNITY PLANS

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 98-51, from Councilmember Alan M. Arakawa, requesting discussion on the matter of improving the process to update the general and community plans.
2. A memorandum dated February 24, 1998, from former Councilmember J. Kalani English, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTIONS 2.80A.030 AND 2.80A.050 OF THE MAUI COUNTY CODE, RELATING TO CITIZEN ADVISORY COMMITTEES". The purpose of the draft bill is to have each citizen advisory committee become the final body to review a community plan prior to referral to the Council.
3. A memorandum dated May 5, 1998, from Councilmember Alan M. Arakawa, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE REPEALING CHAPTER 2.80A OF THE MAUI COUNTY CODE AND ADOPTING A NEW CHAPTER 2.80A RELATING TO AMENDING AND UPDATING GENERAL AND COMMUNITY PLANS". The purpose of

the draft bill is to incorporate deadlines into the general and community plan update process.

4. A memorandum dated February 7, 2002, from the Committee Chair, transmitting proposed amendments to Chapter 8, Charter of the County of Maui, relating to the Department of Planning.

STATUS:

The Committee previously met on this matter and deferred action pending further discussion. Wilson W. Orr, Director of the NASA Program at Prescott College, Arizona, will make a Geographic Information System presentation on planning and coping with growth. The Committee will discuss and consider various methods to improve the general and community plan update processes and determine whether any legislative action is warranted. The Committee will also consider whether to recommend that the Charter Commission consider proposed amendments to Chapter 8, Charter of the County of Maui. The Committee may consider other related action, including the possible filing of County Communication No. 98-51.
