PC-8 IMPROVING THE PROCESS FOR UPDATING THE GENERAL AND COMMUNITY PLANS

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 98-51, from Councilmember Alan M. Arakawa, requesting discussion on the matter of improving the process to update the general and community plans.
2. Planning Committee Report No. 02-43, dated March 15, 2002, recommending adoption of a resolution proposing amendments to the Charter of the County of Maui, relating to the Department of Planning.
