### **IMPROVING THE PROCESS FOR UPDATING THE GENERAL AND COMMUNITY PLANS**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. County Communication No. 98-51, from Councilmember Alan M. Arakawa, requesting discussion on the matter of improving the process to update the general and community plans.
2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.80A OF THE MAUI COUNTY CODE PERTAINING TO GENERAL PLANS, AND COMMUNITY PLANS". The purpose of the proposed bill is to amend the general and community plan update process by requiring, among other things:
  - a. an island-wide land use strategy for Maui, Molokai and Lanai, developed by a general plan advisory committee, and driven by a managed and directed growth plan, and urban and rural growth boundaries;
  - b. implementation programs for the general and community plans containing numeric prioritization of implementing actions, identification of funding sources, benchmarks, and annual status reports; and

- c. staggered consideration of community plan updates based upon the date of each plan's prior adoption.

**STATUS:** The Committee will discuss and consider the proposed bill, and other methods to improve the general and community plan update process. The Committee may determine whether any legislative action is warranted. The Committee may also consider other related action, including the possible filing of County Communication No. 98-51.
