Chair and Members:

Your Public Works and Transportation Committee, having met on February 28, 2001, makes reference to County Communication No. 01-38, from the Director of Public Works and Waste Management, transmitting the following:

1. A proposed resolution entitled "ACCEPTING DEDICATION OF ROADWAY LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of a roadway lot designated as Neki Place in conjunction with the Cabral Subdivision project;
2. A proposed resolution entitled "ACCEPTING DEDICATION OF EASEMENT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of a drainage easement designated as Drainage Easement A in conjunction with the Cabral Subdivision project; and
3. A proposed resolution entitled "ACCEPTING DEDICATION OF EASEMENT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of a drainage easement designated as Drainage Easement B in conjunction with the Cabral Subdivision project.

At its meeting, your Committee met with the Director of Public Works and Waste Management and a Deputy Corporation Counsel.

The Director of Public Works and Waste Management noted that the Cabral Subdivision was completed in 1969. He also clarified that although the roadway was constructed in 1969, the drainage easements were not completed until the year 2000.
