Chair and Members:

Your Public Works and Transportation Committee, having met on August 1, 2001, makes reference to County Communication No. 01-182, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the resolution is to accept the dedication of roadway Lot 5-B, located in the Charles Tavares Tract, for shoulder widening along Makawao Avenue.

At its meeting, your Committee met with the Deputy Director of Public Works and Waste Management and the First Deputy Corporation Counsel.

The Deputy Director of Public Works and Waste Management provided a brief overview of the matter. He indicated that the subject lot is for the purpose of road widening near the corner of Makani Road and Makawao Avenue to correct a site distance problem.

In response to an inquiry from your Committee, the Deputy Director indicated that the lot is 1,187 square feet and will be purchased for \$8,000. Your Committee noted that this appeared to be a substantial amount of money for a small parcel of land; however, your Committee felt that widening of the shoulder would be an improvement to the area.

The First Deputy Corporation Counsel further stated that the resolution could be revised to include both the square footage of the subject property and the sales price.

As a result, your Committee voted to recommend adoption of the revised resolution and filing of the communication.
