Chair and Members:

Your Public Works and Transportation Committee, having met on August 1, 2001, makes reference to County Communication No. 01-196, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "AUTHORIZING THE GRANTING OF AN EASEMENT ON COUNTY OF MAUI REAL PROPERTY TO MAUI ELECTRIC COMPANY, LIMITED, FOR UTILITY PURPOSES".

The purpose of the resolution is to grant a utility easement to Maui Electric Company, Limited, over, across and under TMK: (2) 3-8-046:037 (por.) located in Wailuku.

At its meeting, your Committee met with the Deputy Director of Public Works and Waste Management and the First Deputy Corporation Counsel.

The Deputy Director of Public Works and Waste Management provided a brief overview of the matter. He indicated that the proposed easement is for an existing power line consisting of approximately 156 square feet located adjacent to the Maui Memorial Medical Center in Wailuku.

As a result, your Committee voted to recommend the adoption of the proposed resolution and filing of the communication.
