Chair and Members:

Your Public Works and Transportation Committee, having met on August 15, 2001, makes reference to County Communication No. 01-214, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of roadway Lots 3 and 4, along Pulehu Road, in conjunction with the Buchanan-Lomongo Subdivision, for road widening.

At its meeting, your Committee met with the Deputy Director of Public Works and Waste Management and the First Deputy Corporation Counsel.

The Director of Public Works and Waste Management provided a brief overview of the matter. He noted that Lot 3 is a four foot wide lot approximately 1,240 square feet in size, and Lot 4 is a remnant lot, 134 square feet in size.

Responding to an inquiry by your Committee, the First Deputy Corporation Counsel stated that the purchase prices paid by the County for road widening lots are nominal amounts and are arbitrarily set.

Your Committee voted to recommend the adoption of the proposed resolution and the filing of the communication.

Your Public Works and Transportation Committee **RECOMMENDS** the following:
