Your Public Works and Transportation Committee, having met on September 19, 2001, makes reference to County Communication No. 01-254, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 4, along Lilikoi Road, Haiku, Maui, in conjunction with the Mathilda Carvalho Subdivision, for road widening.

At its meeting, your Committee met with the Director of Public Works and Waste Management and a Deputy Corporation Counsel.

The Director of Public Works and Waste Management provided a brief overview of the matter. He noted that the road widening lot is for a three-lot subdivision in Haiku, and that the lot is 7½ feet wide.
