Your Public Works and Transportation Committee, having met on October 3, 2001, makes reference to County Communication No. 01-267, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROADWAY LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of Lot 298 for road widening purposes along Upper Kimo Drive, Kula, Hawaii, in conjunction with the Tadatsugu Endo Subdivision.

By correspondence dated September 26, 2001 to the Corporation Counsel, your Committee requested that the title of the proposed resolution be revised to be more specific, distinguishing the subject legislation from other legislation on similar matters.

By correspondence dated September 27, 2001, the Department of the Corporation Counsel transmitted a revised resolution entitled "ACCEPTING DEDICATION OF ROADWAY LOT FROM TADATSUGU ENDO REVOCABLE LIVING TRUST, SITUATE IN KULA, MAUI, HAWAII, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE, RELATING TO ACQUISITION OF REAL PROPERTY". The resolution was revised to incorporate reference to the Tadatsugu Endo Revocable Living Trust and other nonsubstantive changes.

At its meeting, your Committee met with the Director of Public Works and Waste Management and the First Deputy Corporation Counsel.

The Director of Public Works and Waste Management provided a brief overview of the matter.
