Chair and Members:

Your Public Works and Transportation Committee, having met on November 14, 2001, makes reference to County Communication No. 01-303, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of Lot 2 for road widening, along `Ili`ili Road, Kihei, Hawaii, in conjunction with the Valpy Subdivision.

By correspondence dated November 7, 2001 to the Corporation Counsel, your Committee requested that the title of the proposed resolution be revised to be more specific, distinguishing the subject legislation from other legislation on similar matters.

By correspondence dated November 7, 2001, the Department of the Corporation Counsel transmitted a revised resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE KAMAOLE BEACH LOTS (AKA VALPY SUBDIVISION) PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The resolution was revised to incorporate reference to the Kamaole Beach Lots in the title of the resolution.

At its meeting, your Committee met with the Deputy Director of Public Works and Waste Management and the First Deputy Corporation Counsel.

The Deputy Director of Public Works and Waste Management provided a brief overview of the matter.

Your Committee voted to recommend the adoption of the revised proposed resolution and the filing of the communication.
