EED-15 FOCUS MAUI NUI FINAL REPORT

DESCRIPTION: The Committee is in receipt of General Communication No. 04-2, from Jeanne Unemori Skog, President & CEO, Maui Economic Development Board, Inc., transmitting the 392-page Focus Maui Nui Final Report dated December 2003. According to the Final Report, Focus Maui Nui brought approximately 1,700 participants into an intensive, participatory process to plan for the future of the County.
