### GLASS RECYCLING FOR LICENSED LIQUOR ESTABLISHMENTS

#### DESCRIPTION:

The Committee is in receipt of County Communication No. 00-296, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 20 OF THE MAUI COUNTY CODE, PERTAINING TO GLASS RECYCLING FOR LICENSED LIQUOR ESTABLISHMENTS". The purpose of the proposed bill is to require licensed liquor establishments to provide for the recycling of glass containers.

**PWT-37            PROPOSED BILL AMENDING TITLE 12, MAUI COUNTY CODE,  
RELATING TO RECYCLED GLASS PRODUCT REQUIREMENTS**

**DESCRIPTION:**    The Committee is in receipt of County Communication No. 00-262, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 12 OF THE MAUI COUNTY CODE, PERTAINING TO RECYCLED GLASS PRODUCT REQUIREMENTS FOR COUNTY PUBLIC PROJECTS". The purpose of the proposed bill is to codify the option of using recycled glass in conjunction with County projects.

The purpose of the proposed resolution is to allow Maui Electric Company, Limited, access over, across, through, and under portions of the subject property to maintain and operate its pole, wire, and underground-power lines.

**DESCRIPTION:**     The Committee is in receipt of County Communication No. 01-36, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "AUTHORIZING MAUI ELECTRIC COMPANY, LIMITED, TO PLACE UTILITY POLES ON HAUMANA ROAD, HAIKU, MAUI, HAWAII". The purpose of the proposed resolution is allow Maui Electric Company, Limited, to install nine utility poles on Haumana Road pursuant to Chapter 12.16 of the Maui County Code, which provides that the placement of electric poles within the County rights-of-way requires the permission of the County Council.
