### **PROPOSED BILL AMENDING CHAPTER 16.12A AND TITLE 16, MAUI COUNTY CODE, PERTAINING TO THE REGULATION OF COMMERCIAL SIGNS ON PRIVATE PROPERTY**

#### **DESCRIPTION:**

The Committee is in receipt of County Communication No. 00-281, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE REPEALING CHAPTER 16.12A, MAUI COUNTY CODE, AND AMENDING TITLE 16, MAUI COUNTY CODE, PERTAINING TO THE REGULATION OF COMMERCIAL SIGNS ON PRIVATE PROPERTY". The purpose of the proposed bill is to incorporate amendments to the Maui County Code to address complaints and concerns relating to the interpretation of existing provisions relating to commercial signs on private property.

**STATUS:** This item is being scheduled to allow the Committee to consider amendments to Title 16 of the Maui County Code. The Committee may recommend the passage of the proposed bill on first reading. The Committee may also consider other related action, including the possible filing of County Communication No. 00-281.

**PWT-2                    TRAFFIC SAFETY AT THE INTERSECTION OF MAKAWAO AVENUE  
AND BALDWIN AVENUE**

**DESCRIPTION:** The Committee is in receipt of County Communication No. 99-182, from former Councilmember John Wayne Enriques, relating to traffic safety at the intersection of Makawao Avenue and Baldwin Avenue.

**STATUS:** This item is being scheduled to allow the Committee to consider a proposal relating to improvements at the intersection of Makawao and Baldwin Avenues. The Committee may: (1) authorize the Department of the Corporation Counsel to draft a proposed bill that would provide for the installation of a fourth stop sign at the intersection; and (2) recommend the passage of the proposed bill on first reading. The Committee may also consider other related action, including the possible filing of County Communication No. 99-182.

**DESCRIPTION:** The Committee is in receipt of County Communication No. 00-228, from former Councilmember John Wayne Enriques, transmitting a letter dated July 25, 2000, from Charlie Levy, relating to the rental of portable toilets for the Makawao Parking Lot.

**STATUS:** This item is being scheduled to allow the Committee to consider a proposal regarding the rental of portable toilets at the Makawao Parking Lot. The Committee will consider appropriate action, including the possible filing of County Communication No. 00-288.
