HHS-1 NAMING OF WEST MAUI SENIOR CENTER

DESCRIPTION: The Committee is in receipt of County Communication No. 04-246, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO NAME THE WEST MAUI SENIOR CENTER". The purpose of the proposed bill is to amend the Maui County Code to name the facilities located at 778 Pauoa Street in Lahaina the "West Maui Senior Center".

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No. 04-246 and other related action.

HHS-8 DONATION OF A SPORTS UTILITY VEHICLE

DESCRIPTION: The Committee is in receipt of County Communication No. 04-268, from the Director of Housing and Human Concerns, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION OF A SPORTS UTILITY VEHICLE FROM KULA COMMUNITY FEDERAL CREDIT UNION TO THE DEPARTMENT OF HOUSING AND HUMAN CONCERNS, COUNTY OF MAUI, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE". The purpose of the proposed resolution is to authorize the acceptance of the donation of a 2002 Suzuki Vitara XL7, valued at \$9,150, from the Kula Community Federal Credit Union to the Department of Housing and Human Concerns for use by its Kaunoha Senior Services Division for transportation purposes.
