### **PROPOSED RESOLUTION GRANTING AN EASEMENT TO JDI LIMITED PARTNERS FOR ACCESS PURPOSES**

**DESCRIPTION:**

The Committee is in receipt of County Communication No. 99-208, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "AUTHORIZING THE GRANTING OF AN EASEMENT ON COUNTY OF MAUI REAL PROPERTY TO JDI LIMITED PARTNERS FOR ACCESS PURPOSES". The purpose of the proposed resolution is to grant an easement to JDI Limited Partners across the County's public parking lot located at the corner of Front Street and Prison Street in Lahaina.
