PWT-42 RENAMING A PORTION OF OLD MAKENA ROAD AKA MAKENA KEONEOIO ROAD

DESCRIPTION: The Committee is in receipt of County Communication No. 01-117, from the Director of Public Works and Waste Management, relating to the Commission on Naming Streets, Parks and Facilities recommendation to deny a request to rename a portion of Old Makena Road aka Makena Keoneoio Road to Kukahiko Road.

STATUS: The Committee will consider whether any legislative action is warranted on this item. The Committee may also consider other related action, including the possible filing of County Communication No. 01-117.

PWT-2 TRAFFIC SAFETY AND THE INTERSECTION OF MAKAWAO AVENUE AND BALDWIN AVENUE

DESCRIPTION: The Committee is in receipt of County Communication No. 99-182, from former Councilmember John Wayne Enriques, relating to traffic control at the intersection of Makawao Avenue and Baldwin Avenue.

STATUS: At the Committee meeting of February 14, 2001, the Director of Public Works and Waste Management agreed to monitor the effectiveness of a temporary four-way stop at the subject intersection and to refer the matter to the Traffic Safety Council for review. The Director has transmitted information relating to the effectiveness of the temporary four-way stop and a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.44, MAUI COUNTY CODE, PERTAINING TO STOP REQUIRED". The purpose of the proposed bill is to install a permanent four-way stop at the intersection of Baldwin Avenue and Makawao Avenue. The Committee will consider whether to recommend the passage of the proposed bill on first reading. The Committee may also consider other related action, including the filing of County Communication No. 99-182.

PWT-58 PROPOSED RESOLUTION ACCEPTING DEDICATION OF ROAD WIDENING LOT (OLINDA HOUSE LOTS SUBDIVISION)

DESCRIPTION: The Committee is in receipt of County Communication No. 01-167, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of a roadway lot, Lot 7-B, in conjunction with the Olinda House Lots Subdivision.
