**PWT-47                    PROPOSED BILL AMENDING CHAPTER 10.76, MAUI COUNTY CODE, PERTAINING TO PARKING LOTS AND PIERS**

**DESCRIPTION:**     The Committee is in receipt of County Communication No. 01-212, from the Director of Public Works and Waste Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 10.76, MAUI COUNTY CODE, PERTAINING TO PARKING LOTS AND PIERS". The purpose of the proposed bill is to add Section 10.76.075, to prohibit commercial or business activity from taking place at the Makawao Veterans' Cemetery parking lot and to establish a penalty.
