MAUI'S TRAFFIC SITUATION

DESCRIPTION:

The Committee is in receipt of County Communication No. 01-85, from Councilmember Michael Molina, relating to Maui's traffic situation.

PWT-2 MOLOKA`I LANDFILL

DESCRIPTION: The Committee is in receipt of County Communication No. 01-236, from the Director of Public Works and Waste Management, requesting that the Fiscal Year 2002 Budget be amended to change the Moloka`i Landfill free day from every Sunday to every Saturday.

DESCRIPTION: By County Communication No. 01-238, the Director of Public Works and Waste Management transmitted a proposed resolution entitled "ACCEPTING DEDICATION OF KUALAPU`U ROADWAY LOTS PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept the dedication of roadway Lots 181, 182, 183, 216, 217, 218, 144, 145, 146, 147, 148, 149, 150 and 151, in conjunction with an experimental and demonstration housing project in Kualapu`u on Molokai.
