Chair and Members:

Your Housing and Human Services Committee, having met on November 29, 2004, makes reference to County Communication No. 04-268, from the Director of Housing and Human Concerns, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION OF A SPORTS UTILITY VEHICLE FROM KULA COMMUNITY FEDERAL CREDIT UNION TO THE DEPARTMENT OF HOUSING AND HUMAN CONCERNS, COUNTY OF MAUI, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to authorize the acceptance of the donation of a 2002 Suzuki Vitara XL7, valued at \$9,150, from the Kula Community Federal Credit Union to the Department of Housing and Human Concerns for use by its Kaunoa Senior Services Division for transportation purposes.

At its meeting, your Committee met with the Director of Housing and Human Concerns and a Deputy Corporation Counsel.

There was no public testimony.

The Director of Housing and Human Concerns noted that the Kula Community Federal Credit Union has generously donated a number of vehicles to the County over the years. She informed your Committee that the Department is grateful for the donation, which could be used for Kaunoa's Assisted Transportation/Outreach Program, Kaunoa's Meals on Wheels Program, or a variety of other uses.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
