Chair and Members:

Your Housing and Human Services Committee, having met on November 29, 2004, makes reference to County Communication No. 04-246, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO NAME THE WEST MAUI SENIOR CENTER".

The purpose of the proposed bill is to amend the Maui County Code to name the facilities located at 778 Pauoa Street in Lahaina the "West Maui Senior Center".

Your Committee notes that an array of senior programs are provided by the Kaunoa Senior Services Division of the Department of Housing and Human Concerns at the facilities, which opened on September 13, 2004.

At its meeting, your Committee met with the Director of Public Works and Environmental Management, the Director of Housing and Human Concerns, and a Deputy Corporation Counsel.

There was no public testimony on the matter.

The Director of Housing and Human Concerns stated that the Department supports the proposal.

The Director of Public Works and Environmental Management informed your Committee that the Commission on Naming Streets, Parks and Facilities recommended that the Council approve the naming of the facilities as the West Maui Senior Center. The name was proposed by the West Maui senior program participants and the Kaunoa Senior Services Division.

Your Committee voted to recommend passage of the proposed bill on first reading and filing of the communication.
