### **REQUEST FOR WAIVER OF PARK DEDICATION REQUIREMENTS FOR NORTH SHORE VILLAGE SUBDIVISION (PAIA)**

**DESCRIPTION:**

The Committee is in receipt of County Communication No. 04-63, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "APPROVING THE WAIVER OF CERTAIN PARK REQUIREMENTS FOR A PRIVATELY OWNED PARK PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE, FOR THE NORTH SHORE VILLAGE SUBDIVISION". The purpose of the proposed resolution is to approve the waiver of the requirements to provide comfort stations and parking for a privately owned and maintained park, comprising approximately 8,094.5 square feet in the North Shore Village Subdivision in Paia (TMK No. 2-6-05:007, 008 and 009).

**PA-7                    PROTECTING AGRICULTURE INDUSTRY FROM INVASIVE SPECIES**

**DESCRIPTION:**

The purpose of the proposed resolution is to urge the Administration and the Maui Planning Commission to expedite review and approval of permits for the proposed Invasive Species Interdiction Inspection Facility and complementary facilities at the Kahului Airport and urging the State to promptly and fully staff the facilities with qualified personnel.
