### PA-11 REQUEST FOR WAIVER OF PARK DEDICATION REQUIREMENTS FOR KENOLIO MAUKA SUBDIVISION (KIHEI)

**DESCRIPTION:** The Committee is in receipt of County Communication No. 04-206, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "APPROVING THE WAIVER OF CERTAIN PARK REQUIREMENTS FOR A PRIVATELY OWNED PARK PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE, FOR THE KENOLIO MAUKA SUBDIVISION, KIHEI, MAUI, HAWAII". The purpose of the proposed resolution is to approve the developer's request to waive comfort stations and parking requirements for a privately owned and maintained park, comprising approximately 1,833 square feet in the Kenolio Mauka subdivision on Ho'oiki Place in Kihei (TMK: (2) 3-9-028:021).

**STATUS:** The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider the possible filing of County Communication No. 04-206 and other related action.
