**PRIVATE MAINTENANCE OF STREET TREES**

**DESCRIPTION:**

The Committee is in receipt of County Communication No. 04-205, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 12.24A.070, MAUI COUNTY CODE, RELATING TO PLANTING OF STREET TREES". The purpose of the proposed bill is to require the private maintenance of street trees in subdivisions containing four or more lots.

**STATUS:**

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No. 04-205 and other related action.
