S-OLS 1 OUTDOOR LIGHTING STANDARDS

DESCRIPTION: At its meeting of December 5, 2001, the Maui County Council's Public Works and Transportation Committee established the Subcommittee on Outdoor Lighting Standards. The objective of the Subcommittee is to provide recommendations on a draft bill, now entitled "A BILL FOR AN ORDINANCE AMENDING TITLE _____, MAUI COUNTY CODE, RELATING TO OUTDOOR LIGHTING STANDARDS". The purpose of the draft bill is to limit degradation of the night visual environment by minimizing light glare, pollution or trespass through regulation of form and use of outdoor lighting. The lighting standards should reflect considerations in the areas of science, environment, national defense and energy conservation.

STATUS: At its meeting of January 17, 2002, and January 24, 2002, the Subcommittee deferred consideration of this item pending further discussion. The Subcommittee may consider

whether to recommend passage of the draft bill on first reading, with or without revisions. The Subcommittee may also consider other related action.
