S-OLS 1 OUTDOOR LIGHTING STANDARDS

DESCRIPTION: At its meeting of December 5, 2001, the Maui County Council's Public Works and Transportation Committee established the Subcommittee on Outdoor Lighting Standards. The objective of the Subcommittee is to provide recommendations on legislation establishing outdoor lighting standards. By letter dated October 15, 2002, the Department of the Corporation Counsel transmitted a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 2, 12, AND 20, MAUI COUNTY CODE, RELATING TO OUTDOOR LIGHTING STANDARDS". The purpose of the draft bill is to limit degradation of the night visual environment by minimizing light glare, pollution, and trespass through regulation of the form and use of outdoor lighting.

STATUS: The Subcommittee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. The Subcommittee may also consider other related action.
