Chair and Members:

Your Parks and Agriculture Committee, having met on December 2, 2004, makes reference to County Communication No. 04-269, from the Director of Parks and Recreation, transmitting a report regarding park dedications for the first quarter of Fiscal Year 2005 (July 1, 2004 through September 30, 2004).

Your Committee notes that Section 18.16.320(L) of the Maui County Code was established by Ordinance No. 3158, which became effective on February 6, 2004. Section 18.16.320(L) requires the Department of Parks and Recreation to produce semi-annual reports on park dedications, including the quantity of dedicated money and land, within thirty days after the end of the first and third quarter of the fiscal year.

By correspondence dated November 12, 2004, the Council Chair transmitted correspondence dated November 9, 2004, from the Director of Parks and Recreation, transmitting a revised semi-annual report regarding park dedications for each community plan area for the period of April 1, 2004 through September 30, 2004.

At its meeting, your Committee met with the Deputy Director of Parks and Recreation; the Chief of Planning and Development, Department of Parks and Recreation; and a Deputy Corporation Counsel.

There was no public testimony.

The Deputy Director of Parks and Recreation provided a brief overview of the revised semi-annual report. He stated that the report includes a legend, which clearly denotes the formulas used under the current and previous ordinances to calculate park dedication requirements.
