RESEEDING AND REGRASSING OF KOELE GOLF COURSE

DESCRIPTION:

By County Communication No. 00-100, the Council Chair transmitted a letter from Lana`i Company, Inc., transmitting a draft resolution entitled "RESOLUTION GRANTING APPROVAL FOR THE RESEEDING OR RE-GRASSING OF FOUR FAIRWAYS OF THE KOELE GOLF COURSE BETWEEN MID MAY AND MID SEPTEMBER, 2000 WITH POTABLE WATER FROM THE HIGH LEVEL AQUIFER". The purpose of the draft resolution is to approve reseeding and/or regrassing at the Koele golf course on Lana`i, pursuant to Section 19.71.055, Maui County Code. The Committee has been advised that Lana`i Company Inc. has subsequently requested that the draft resolution be amended to approve reseeding or regrassing during 2001.
